#### **½ COMBINED DIFFERENCE HANDICAP ALLOWANCE**

**(COMPETITORS MUST HAVE PLAYED IN 3 HANDICAP QUALIFYING ROUNDS BETWEEN 1 MAY 07 – 5 MAY 08 )**

IF AFTER 18 HOLES THE MATCH IS ALL SQUARE ,A SUDDEN DEATH PLAY OFF COMES INTO FORCE. PAIRS WHO RECEIVED STROKES IN NORMAL PLAY ALSO RECEIVE THEM IN SUDDEN DEATH.

### **RULES OF ENTRY AND PLAY**

ALL PAIRS SHOULD BE AVAILABLE TO PLAY THEIR MATCHES IN "NORMAL TIMES"..... I.E. REGULARLY AVAILABLE AT WEEKENDS AND EVENINGS. PLEASE DO NOT ENTER IF  
**a)** you are planning a long holiday , or are in the Forces and you know that you are to be away on detachment. **b)** as a pair you can only play during a week, or only at the week end.

**THE TOP NAMED PAIR IN EACH DRAWN TIE WILL BE RESPONSIBLE FOR CONTACTING THE PAIR ON THE BOTTOM OF THE DRAW , AND ARRANGING THE FIXTURE. THREE DATES/TIMES SHOULD BE OFFERED: ONE DATE OFFERED MUST BE AT THE WEEK END , ONE DATE MUST BE DURING THE WEEK.**

TOP NAMED PAIRINGS SHOULD MAKE EVERY EFFORT TO CONTACT THEIR OPPONENTS WITHIN 7 DAYS OF THE PREVIOUS ROUND CLOSING. IF UNSUCCESSFUL AFTER 7 DAYS THE TOP NAMED PAIR SHOULD CONTACT THE DIRECTOR OF GOLF TO INFORM HIM THAT CONTACT HAS NOT BEEN MADE.

IF BY FIVE DAYS FROM THE ROUND CLOSING NO ATTEMPT WAS MADE BY THE TOP PAIR TO CONTACT THEIR OPPONENTS THE TOP PAIR SHALL AUTOMATICALLY FORFEIT THE TIE.

**IF MATCHES ARE NOT COMPLETE BY DATES SPECIFIED BOTH PAIRS WILL BE DISQUALIFIED, (UNLESS IN EXCEPTIONAL CIRCUMSTANCES THE COMMITTEE DEEM OTHERWISE)(i.e. bottom named pair not contacted )**

**TO ENTER PLACE A FEE OF £5.00 (per pair) IN AN ENVELOPE , WHICH CLEARLY STATES YOUR NAMES , DATE & TIME , CONTACT TELEPHONE No's. AND "WILSON CUP" , AND POST INTO THE FEES BOX IN RECEPTION.**

**CLOSING DATE FOR ENTRY IS 6<sup>TH</sup> MAY 2008**  
**OR BEFORE WHEN MAXIMUM OF 32 PAIRS IS REACHED.**

IF YOU HAVE NOT PAID BY THIS DATE YOU WILL NOT BE ENTERED.(PLEASE CHECK THAT YOUR NAMES ARE ON THE PAID LIST IN RECEPTION WHICH IS UPDATED ON A REGULAR BASIS.
